

Assignments following the 27th FIAC Plenary Session

1. Approve the list of priority activity areas for the Foreign Investment Advisory Council in Russia in 2014, as outlined in the Communiqué of the 27th Session of the Foreign Investment Advisory Council in Russia.

2. Ministry of Economic Development (A.V. Ulyukaev)
Federal executive bodies (as listed)

Arrange the consideration of proposals and recommendations of the Foreign Investment Advisory Council in Russia with the involvement of stakeholder organizations and the Bank of Russia.

Report results to the Government of the Russian Federation.

Deadline: July 2014.

Submit to the Government of the Russian Federation, in accordance with the established procedure, an agreed draft of a federal law that will amend the provisions of Federal Law No. 416-FZ of 7 December 2011, *On Water Supply and Wastewater Disposal*, concerning the date on which Chapter 5 of the law becomes effective.

Develop in collaboration with stakeholder federal executive bodies and the business community, and submit to the Government of the Russian Federation, in accordance with the established procedure, agreed law amendment proposals that will ensure clear segregation of responsibilities for treatment of industrial wastewater between centralized wastewater systems and customers of those systems, and establish reasonably practicable rates for discharging pollutants into water bodies and centralized wastewater systems, based on experience of member-countries of the Organization for Economic Co-operation and Development (OECD).

Refine in collaboration with the business community and submit to the Government of the Russian Federation, in accordance with the established procedure, drafts amendments to draft Federal Law No. 584399-5, *On Introducing Changes to Federal Law, On Production and Consumption Waste, and Other Legislative Acts of the Russian Federation*, which should provide economic incentives for waste management activities, pursuant to Instruction of the President of the Russian Federation No. Pr-929 of 26 April 2013, so as to ensure the intended use of resources of the public fund in which recycling fees are accumulated, and to create equal conditions for Russian manufacturers and importers, taking into account the circulation of goods within the Customs Union and introduction of a transition period for setting up a waste management system.

Refine in collaboration with the business community and submit to the Government of the Russian Federation, in accordance with the established procedure, proposed amendments to draft Federal Law No.451173-5, *On Introducing Changes to Certain Legislative Acts of the Russian Federation (on Measures to Prevent Employers from Avoiding Employment Contracts by Unjustifiably Concluding Civil Law Contracts, Using 'Agency Labor' Mechanisms or Other Means)*, which should provide for a simplified secondment procedure to be used by legal entities within a group of companies and by private employment agencies, subject to meeting employee interests.

Deadline: December 2013

7. Federal Customs Service (A.Yu. Belyaninov)

Ministry of Economic Development (A.V. Ulyukaev)

Examine in collaboration with the business community whether it is possible to ensure control and identification of goods owned by an authorized economic operator and placed in temporary storage warehouses owned by third parties. Submit relevant proposals to the Government of the Russian Federation.

8. Ministry of Agriculture (N.V. Fedorov)

Federal Service for Veterinary and Phytosanitary Supervision (S.A. Dankvert)

Ministry of Economic Development (A.V. Ulyukaev)

Examine in collaboration with stakeholder federal executive bodies the redistribution of duties between federal executive bodies and executive bodies of the constituent entities of the Russian Federation, in particular, the transfer to the federal level of duties in the area of state veterinary supervision of goods exports.

Submit relevant proposals to the Government of the Russian Federation in accordance with the established procedure.
