~~I. Instructions of the Russian government that have not been carried out~~

(V. R. Venchikova, A. V. Chibis, V. N. Borovoy)

1. Note the position of the Ministry of Natural Resources (V. R. Venchikova) on amendments to the method of calculating discharge standards (approved by the ministry's Order No. 333 of 17 December 2007).

2. Recommend that the Ministry of Construction and Housing (A. V. Chibis) hold a meeting to agree draft amendments to Government Decree No. 644 of 29 July 2013 "On Approval of the Rules of Cold Water Supply and Drainage and on Amendments to Certain Acts of the Government of the Russian Federation" and submit the agreed version to the Russian Government by 19 October 2015.

3. Note the position of the Ministry of Agriculture (V. N. Borovoy) on the publication of a ministry order that would, by 1 January 2018, remove finished dairy products from the list of products requiring veterinary certification.

4. Note the position of the Ministry of Agriculture (V. N. Borovoy) on the fulfillment of the government instruction on the publication of clarifications of the Federal Law "On Plant Quarantine" on the ministry's official website.

## II. Consideration of recommendations made by FIAC

(A. Grigoryev, V. Vlasov, H. Ashur, J. Raman, A. S. Tsydenov, R. V. Starovoit, V. S. Osmakov, M. V. Chemerisov)

1. Note FIAC's concern over the amount of fees imposed to compensate for damage done to federal public motor roads by vehicles with a gross vehicle weight rating of over 12 tons.

2. Note FIAC's concern about the preparation of draft amendments to Federal Law No. 381-FZ of 28 December 2009 "On the Principles of the State Regulation of Trade in the Russian Federation."

3. Recommend that the Ministry of Industry and Trade (V. S. Osmakov) send draft amendments to Federal Law No. 381-FZ of 28 December 2009 "On the Principles of the State Regulation of Trade in the Russian Federation" to the Ministry for Economic Development and hold a meeting by 19 October 2015 with representatives of the Ministry for Economic Development and FIAC to discuss the key provisions of these draft amendments.

4. The Ministry of Economic Development (M. V. Chemerisov) is to send FIAC a prepared draft federal law "On Amendments to the Federal Law 'On the Contract System for the Procurement of Goods, Work and Services for State and Municipal Needs.'"
