LIST OF INSTRUCTIONS

pursuant to a meeting of the Executive Committee of the Foreign Investment Advisory Council in Russia (FIAC) on 23 April 2015

1. Ministry of Agriculture (A. N. Tkachev)
Ministry of Economic Development (A. V. Ulyukaev)
Ministry of Justice (A. V. Konovalov)
Federal Consumer Rights and Welfare Service (A. Yu. Popova)

Jointly with industry unions (associations) and the FIAC Working Group for Trade and the Consumer Sector, study the possibility of amending Order No. 281 of the Russian Ministry of Agriculture of 17 July 2014 "On Approval of the Rules for the Preparation of Supporting Veterinary Documents and the Procedure for Preparing Electronic Supporting Veterinary Documents" to correct certain entries in the list of controlled products for which veterinary supporting documents will be required from 1 February 2017, paying special attention to finished (processed) food products.

Report the results to the Government of the Russian Federation before 1 July 2015.

Ministry of Natural Resources and Environmental Protection (S. E. Donskoy)
Ministry of Economic Development (A. V. Ulyukaev)

Jointly with the FIAC Working Group on Technical Regulation and Elimination of Administrative Barriers, develop agreed proposals for amendments to Decree No. 644 of the Government of the Russian Federation of 29 July 2013 "On Approval of the Rules of Cold Water Supply and Drainage and on Amendments to Certain Acts of the Government of the Russian Federation" in order to:

- bring indicators of pollutants into line with scientifically valid indicators
- make it possible to achieve the required level of wastewater treatment under the service agreement with centralized drainage systems

Report the results to the Government of the Russian Federation before 1 July 2015.

Ministry of Economic Development (A. V. Ulyukaev)

With the involvement of the FIAC Working Group on Technical Regulation and Elimination of Administrative Barriers, ensure the immediate submission of the Russian Government's draft amendments to draft Federal Law No. 386179-6 "On Amendments to the Federal Law 'On Water Supply and Drainage' and Certain Legislative Acts of the Russian Federation" to allocate responsibility for industrial waste treatment between centralized drainage networks and their subscribers as well as to set achievable standards for pollutant discharges into centralized drainage networks.

Deadline: 15 June 2015

Ministry of Economic Development (A. V. Ulyukaev)

Jointly with the FIAC Working Group on Technical Regulation and Elimination of Administrative Barriers, develop criteria for assigning companies to the regulated categories established in Decree No. 230 of the Government of the Russian Federation of 18 March 2013 "On Categories of Subscribers Whose Facilities Are Subject to Standards of Permissible Discharges of Pollutants and Other Substances and Microorganisms."

Deadline: 1 July 2013

5. Ministry of Agriculture (A. N. Tkachev)

Jointly with concerned federal executive bodies, and with the involvement of the FIAC Working Group for Trade and the Consumer Sector, taking into account previous instructions of the Government of the Russian Federation, ensure that regulatory acts of the Government of the Russian Federation are prepared and submitted to the Government of the Russian Federation and that departmental acts necessary for the implementation of the Federal Law "On Plant Quarantine" are adopted.

Report the results to the Government of the Russian Federation.

6. Ministry of Agriculture (A. N. Tkachev)
Ministry of Economic Development (A. V. Ulyukaev)

With the involvement of the FIAC Working Group for Trade and the Consumer Sector, prepare clarifications of the Federal Law "On Plant Quarantine" and publish them on the official Internet site of the Russian Ministry of Agriculture.

Report the results to the Government of the Russian Federation before 15 September 2015.

7. Ministry of Natural Resources and Environmental Protection (S. E. Donskoy)
Ministry of Construction and Housing (M. A. Men)
Ministry of Economic Development (A. V. Ulyukaev)

For purposes of implementing the provisions of Federal Law No. 458-FZ of 29 December 2014 "On Amendments to the Federal Law 'On Production and Consumption Waste' and Certain Legislative Acts of the Russian Federation and the Annulment of Certain Legislative Acts (Provisions of Legislative Acts) of the Russian Federation," jointly with the FIAC Working Group on Technical Regulation and Elimination of Administrative Barriers, study the possibility of setting the recycling standard for all types of recyclable packaging and environmental fees at a zero level for the period of 2015-16.

Report the results to the Government of the Russian Federation before 1 July 2015. Submit draft legislation if necessary.
